Re: **Must Carry Election**

Dear Sir or Madam:

The Satellite Home Viewer Improvement Act of 1999 (“SHVIA”) and the Satellite Home Viewer Extension and Reauthorization Act of 2004 (“SHVERA”) require that you carry all local stations in a market where you carry at least one station pursuant to a compulsory copyright license, and the Federal Communications Commission’s Rules and Regulations implementing SHVIA and SHVERA requires us to make an election such carriage.

Section 76.66(d)(3) of the FCC’s Rules provides that new television stations (i.e., stations providing over-the-air service in a market for the first time on or after July 1, 2001) have the right to make their carriage election during the period beginning 60 days prior to commencing broadcasting and ending 30 days after commencing broadcasting. Entravision Holdings, LLC is the licensee of television station KDCU licensed to Wichita, Kansas (the “Station”), and we currently expect that the Station will commence broadcasting on or around August 1, 2009. Consequently, the instant carriage election is timely submitted.

We hereby elect carriage by must-carry for the Station in the Wichita-Hutchinson Plus Nielsen Designated Market Area (DMA) so that the Station's signal is required to be available to all of your company's subscribers in the DMA.

Further, in accordance with Section 76.66(d)(1)(iii) of the Commission’s Rules, we hereby provide you with the following information:
