## **ISSUES AND PROGRAMS REPORT**

### **OVERVIEW**

The following is the quarterly "Issues and Programs" Report placed in the public file of WNEM October 10, 2007. The report covers the period from July 1 through September 30, 2007. The report is based on ten significant problems and needs determined by WNEM's community ascertainments. Below each problem/need is a brief description of some news segments broadcast during the quarter designed to call attention to, or address, the problem or need.

**1. Job Market**

NOON	LOC/NEWS	7/2/07 :26
The Jobs Bank is expected to be a key issue between automakers and the UAW. The Program costs millions to operate and was created in exchange for the UAW's help in making auto plants more flexible and automated.		

530PM	LOC/NEWS	7/9/07 :16
Many companies who build highways across the state are laying off workers. Several factors, including a weak Michigan economy have left less money available to fund infrastructure projects.		

WEEKEND WAKEUP	LOC/NEWS	7/21/07 :16
The \$1 billion expansion project has started for the Hemlock semi-conductor plant. This includes a job fair today in Saginaw. Delta College and MI Works will also be there.		

5PM	LOC/NEWS	7/31/07 1:32
Investors in Flint have announced that hundreds of jobs could be coming to the area. The Buick City complex, which has sat vacant since 1999, could now become an international hub for business, creating many jobs in the process.		

WAKEUP	LOC/NEWS	8/1/07 :17
Investors in Flint have announced that hundreds of jobs could be coming to the area. Mid-Michigan Global Link wants to turn the 220-acre Old Buick City site into a freight center, that can handle "rail to freight" shipping traffic. It will be called the Great Lakes Global Gateway, and will create up to 600 new jobs.		

WAKEUP	NAT/NEWS	8/12/07 1:34
Recent coal-mining cave-ins are reminders that coal mining can be life-risking work. Professions that are high on the "deadliest jobs" list are fisherman, loggers, iron and steel works, and coal miners. Following these top contenders are refuse collectors, farmers and ranchers, power line workers, roofers, and people who drive a lot for their jobs.		

11PM LOC/NEWS 8/13/07 1:12  
The Saginaw County Community Mental Health Authority is looking at possible outsourcing of jobs. Leaders of their union say the outsourcing could lay off almost 70 workers and cut services to the disabled. Union members are willing to accept pay and benefit cuts to keep their jobs.

6PM LOC/NEWS 8/29/07 1:20  
The news Saginaw Chippewa gambling facility in Arenac County will employ 300 workers. The job list includes everything from managerial and maintenance positions to working food service and security. This employment will spawn growth for the surrounding communities of Standish and Pinconning.

530PM LOC/NEWS 9/7/07 :16  
A new report shows three Michigan colleges generated about 68,000 jobs and contributed nearly \$13 billion to the State's economy last year. U of M, MSU and Wayne State are the three that spark the State's economy.

11PM LOC/NEWS 9/23/07 :20  
Joblessness in Michigan, already at its highest rate since 1993, is likely to get worse in the months ahead. According to a new U of M forecast, economists say Michigan is likely to lose nearly 69,000 jobs this year, which is 20,000 more lost jobs than was predicted for 2007 in May's forecast.

## 2. Economy/Budgets

530PM LOC/NEWS 7/10/07 :21  
The Flint City Council tabled discussion on nearly all 2008 budget items until July 23. This delay threatens to jeopardize key funding projects such as a nearly \$7 million grant for road improvements. The Council and Mayor Don Williamson have been at odds over spending priorities.

6PM LOC/NEWS 7/16/07 1:25  
The Michigan Secretary of State, Terry Lynn Land, has announced she plans to close the Secretary of State office located in Buena Vista Township, and install automated Machines to help distribute license tabs. For all other transactions, folks will have to travel to the Saginaw Township branch.

NOON LOC/NEWS 7/18/07 :10  
State lawmakers are back in Lansing from vacation to face Michigan's \$1.6 billion budget deficit. The fiscal year starts October 1. Governor Granholm is pushing for prompt legislative action.



NOON LOC/NEWS 9/10/07 :19  
State legislators and Governor Granholm discuss the best way to close a \$1.75 billion deficit before the start of the next fiscal year. Republicans who run the Senate, Democrats who control the House, and the Governor's office are divided over various tax increase plans.

WAKEUP LOC/NEWS 9/14/07 :18  
The State House is expected to vote today on a proposal to raise personal income taxes. Other ideas being discussed include imposing a tax on services and entertainment. This comes as lawmakers try to balance the budget for the upcoming fiscal year.

6PM LOC/NEWS 9/17/07 :26  
Lawmakers are deadlocked on a proposal to raise the State's income tax from 3.9 percent to 4.6 percent. That would eliminate a large part of a budget deficit projected for next fiscal year, which begins October 1. Despite a very long weekend of negotiations, there has been little visible progress.

11PM LOC/NEWS 9/26/07 1:54  
The State of Michigan is just five days away from a government shutdown, unless a budget deal is reached. Right now, lawmakers need to come to a consensus on how to balance the \$1.75 billion deficit. If the deal isn't reached, the paperwork of shutting down an entire state will begin.

11PM LOC/NEWS 9/30/07 1:39  
The main issue of the new budget is whether or not to raise taxes. Raised taxes will extend the budget and buy lawmakers time to balance it. Another aspect of the agreement would be to apply Michigan's 6 percent sales tax to a number of services, like cable television.

### 3. Crime

11PM LOC/NEWS 7/11/07 1:13  
Two young girls were approached today by a man driving a black pickup truck. The 7-year-old sensed something wasn't right, grabbed her sister's hand and they ran towards their Corunna apartment. Police sent out a bulletin, telling officers to keep an out for the vehicle with a description of the driver. The suspect was never found, which has parents worried.

11PM LOC/NEWS 7/12/07 1:15  
The Crime Prevention Council encourages groups to be aware of crime in their neighborhood. The Covenant Neighborhood Association cares enough to team up with local law enforcement, promoting clean ups of vacant lots and abandoned homes, which are crime magnets.

5PM NAT/NEWS 7/16/07 1:20  
As Americans face new terrorist threats, U.S. cities are eyeing up high tech surveillance systems, like the new \$90 million New York initiative which installed 3,000 cameras. The cameras track car movements with technology that recognizes and records every license plate seen. The new program includes face recognition and helmet cameras.

NOON LOC/NEWS 7/26/07 :21  
A committee called "Parishioners on Patrol" is preparing to host a street witness training session. Attendees will learn guidelines for effective observation of street crimes.

6PM LOC/NEWS 8/1/07 1:17  
Witnesses tell Saginaw police of shots fired in a Bridgeport hotel parking lot, and then a fight ensues inside the building, while guests scrambled to safety. A 17-year-old Saginaw resident suffered gunshot wounds that were non-life threatening.

11PM LOC/NEWS 8/15/07 1:54  
A young mother's life was taken in the early morning hours, marking the 14<sup>th</sup> shooting for the City of Saginaw this year. A local minister forms a movement called "Save Ourselves" which now has approximately 50 members. They hold rallies and meetings, and even attend funerals of gang members, hoping to connect in a positive way.

11PM LOC/NEWS 8/16/07 1:15  
A 26-year-old woman was killed and her 22-year-old brother critically injured outside a house on North Webster Street. The incident happened after the siblings attended a birthday party at the home. The woman leaves behind five children.

5PM LOC/NEWS 9/17/07 :17  
The Saginaw and Flint Police Department will receive federal money to help fight gun violence and gangs. The \$1 million grant will be split between Saginaw, Flint and the Jackson, Michigan departments.

NOON LOC/NEWS 9/19/07 :29  
This morning, State Police continue to investigate a fatal shooting at the Lone Pine Motel in Clare. A tazer was used before firing upon William C. Scozari, killing him. The two officers were responding to a complaint of shots being fired, when the suspect allegedly lunged at police with a knife and hatchet.

11PM LOC/NEWS 9/27/07 :35  
Earlier today, on Dearborn Street, shots were fired, sending one right through the window of Masters Court Ministries and a nearby home. Officers did find a gun behind a home. No arrests have been made.

WEEKEND WAKEUP                      LOC/NEWS                      9/29/07                      :24  
The mother of a 3-year-old, who accidentally shot and killed himself, may not face any criminal charges, although she may lose custody of her two other children. The Genesee County prosecutor concluded, after months of investigation, the boy pulled the trigger of a 9 MM gun on his own.

**4. Abuse**

5PM                                      LOC/NEWS                      7/11/07                      :17  
A former Essexville-Hampton school custodian has been bound over for trial. He is accused of slamming a 7-year-old boy into a chair, when the boy called him a name. The misdemeanor could lead to 93 days in jail, and a \$500 fine.

5PM                                      NAT/NEWS                      7/16/07                      1:25  
Victims abused by Catholic priests quietly made their way into a Los Angeles courthouse today. The victims will each receive about a million dollars, but not full satisfaction, as many of the victims wanted full disclosure. The deal will avoid potentially embarrassing revelations in court. More than \$2 billion has been paid out by the Roman Catholic Church for similar cases of abuse.

There has been a delay in the case against a Lapeer County family accused of animal abuse. Three dogs were confiscated during a March raid of a farm in Imlay Township.

11PM                                      NAT/NEWS                      8/10/07                      1:20  
A property manager was arrested after 18 residents were discovered living in an area designated for six residence. The occupants all suffered from heat-related illnesses. The property was operating as an unlicensed assisted living facility, say city officials.

5PM                                      NAT/NEWS                      8/15/07                      :19  
Nearly 90 cats and dogs were discovered inside a multi-million dollar New Jersey mansion, along with 23 dead animals in shoe boxes, stacked in the garage. The owners are now facing animal cruelty charges.

6PM                                      LOC/NEWS                      8/24/07                      :18  
A St. Charles teen is accused of killing two animals and will undergo a psychological examination for feeding them antifreeze. The girl was enrolled in the Veterinary Technician program at Baker College at the time.

11PM                                      LOC/NEWS                      9/1/07                      :20  
A Flint woman faces felony charges for allegedly throwing her neighbor's dog off a 20-foot balcony. The woman faces charges of torturing an animal, a 4-year felony.

530PM NAT/NEWS 9/17/07 :26  
The Roman Catholic diocese of Pittsburgh has created a fund with more than a million dollars in it, to settle 32 lawsuits alleging abuse or injury by priests. The diocese will also offer a program of counseling and healing.

WAKEUP LOC/NEWS 9/18/07 :19  
A Flint woman accused of throwing her roommate's dog off a second floor balcony is pleading "not guilty." If convicted, she faces a two-year sentence. Sadie Mae, the nine-pound puppy, is recovering.

## 5. School Budgets

5PM LOC/NEWS 7/11/07 :16  
Alma Schools are deciding what to do with a million dollar windfall. That's how much was left over after building and remodeling projects came in under budget.

11PM LOC/NEWS 7/14/07 :11  
In Genesee County, the Flint School District received \$750,000 in federal money to fund after-school programs. The youth development programs will include academic and recreational activities.

WAKEUP LOC/NEWS 8/7/07 :19  
A health foundation is giving Michigan and 16 other states \$20 million to promote healthy eating and exercise in schools. The Alliance for a Healthier Generation hopes to attack obesity in children.

6PM LOC/NEWS 8/9/07 :25  
A protest was held by more than a dozen Saginaw School District educators. It happened as an \$8 million budget deficit has forced the school board to cut back on programs.

WAKEUP LOC/NEWS 8/10/07 :24  
There are two six-year terms that will be on the ballot this November. So far only two District residents have requested nomination petitions. The Board is open to people who live in the City of Saginaw, Zilwaukee and Kochville Township.

530PM NAT/NEWS 8/17/07 1:30  
The average family plans to spend just under \$564 this year on back-to-school shopping, Seven percent more than last year. The bulk of the money will go for clothing. Experts say once school starts retailers tend to cut prices, so parents should wait for the bargains.



11PM LOC/NEWS 8/9/07 1:09  
After more than 8 months in Iraq, a soldier returns home and meets his 8-month-old daughter for the first time. The baby was born just one week after Corporal Zachary Wegley of Saginaw County was deployed to Iraq. Wegley will return to duty in two weeks.

11PM LOC/NEWS 8/11/07 1:30  
A community came out to show support for a local fallen hero. Hundreds attended a memorial in Saginaw County for 23-year-old Army Private First Class Charlie Heinlein. Those who knew him, say you can serve his memory by reaching out to servicemen overseas, with a letter or a care package.

11PM LOC/NEWS 8/17/07 1:25  
About 150 families gave their loved ones a hero's welcome at Ferris State University's Wink Arena. It was the 1<sup>st</sup> Battallion 125<sup>th</sup> Infantry Regiment in the Michigan Army National Guard returning home after a year in Iraq.

11PM LOC/NEWS 9/10/07 1:19  
The top U.S. military commander in Iraq, General David Petraeus, presented his report card on the progress of the war, at a Congressional hearing. He said the military objectives of the recent troop build-up, for the most part, are being met.

5PM LOC/NEWS 9/18/07 1:39  
Clare residents say he was a big guy with a big heart. They were referring to Specialist E-4 Tom Motley who lost his life while serving his country. And when he left Pioneer High School, he didn't forget where he came from, because when he came home on leave, he visited the school, and was interviewed by the Media Production class.

530PM LOC/NEWS 9/26/07 :14  
A church and gift store in Traverse City are sending a quarter ton of cherries to soldiers in Iraq and Afghanistan. Some local youth groups will pack the fruit for shipment.

## 7. Recalls

WEEKEND WAKEUP NAT/NEWS 7/14/07 :17  
Gerber is pulling two of their cereals off store shelves after several reports of choking. Apparently some packages contain lumps of cereal that don't dissolve in milk.

WAKEUP NAT/NEWS 7/23/07 :24  
The Castleberry Food Company is recalling more than 80 types of chili and canned meat products. The FDA warns consumers the products may be tainted with a potentially fatal bacteria than can cause botulism. At least four people have gotten sick from the products.

5PM LOC/NEWS 7/23/07 1:30  
A major meat recall affects most of our viewing area. Abbott's Meats Incorporated, based in Flint, is recalling tens of thousands of pounds of meat that could make you sick. Abbott's Meats are sold in Genesee, Saginaw, Bay, Midland, Lapeer and Ingham County stores.

11PM NAT/NEWS 8/4/07 1:37  
The United States and China are trying to agree on safety standards for Chinese imports. The meetings were prompted by a series of recalls of contaminated imports, including millions of children's toys, with lead paint being one of the main problems.

NOON NAT/NEWS 8/8/07 :20  
A New York company is recalling two kinds of toothpaste. The toothpaste was made in China and may contain a chemical, toxic to the kidneys and liver.

5PM LOC/NEWS 8/14/07 1:09  
Some parents are having trouble exchanging recalled toys—the reason is that kids love playing with them. This woman has two daughters who did not wish to part with their Polly Pockets. Fortunately, the Polly Pockets do not involve lead, just loose magnets. If two magnets are swallowed, they can attract to each other, causing a serious blockage. Mattel says at least three children have had surgery for that very reason.

5PM LOC/NEWS 8/15/07 1:06  
There is a test kit, which costs about \$4, to make sure your child's toys are safe. It is for sale at hardware stores and home improvement stores and is simple to use. It checks to see if there is any lead in the paint used on your child's toys.

11PM NAT/NEWS 8/30/07 :17  
A California produce company is recalling bagged fresh spinach after a sample tested positive for salmonella. So far, there have been no reports of illness linked to the tainted spinach.

6PM LOC/NEWS 9/1/07 1:22  
Kroger is recalling all of its Kroger brand mustard and southern-style potato salad, with a "best if used by" date of September 5, 2007, because it may contain e-coli. Kroger Voluntarily pulled it as a precautionary method and are urging customers to check their refrigerators to see if they have purchased it. It can be brought back for a full refund.

5PM NAT/NEWS 9/5/07 1:30  
Mattel has issued another call for 800,000 toys, made in China, with too much lead paint. The products include Barbie furniture, the GEO trax locomotive and Bongo Band drums. Popular Barbie dolls were not recalled. This is the third time in five weeks that Mattel has been forced to recall toys.

11PM NAT/NEWS 9/22/07 :25

About one million Simplicity and Graco cribs are being recalled. The announcement comes after the deaths of three children. The Consumer Product Safety Commission Says the three became entrapped in their cribs and died of suffocation. It appears the drop-rail side of the crib was upside down.

5PM NAT/NEWS 9/28/07 1:15

Kolcraft playpens are being recalled as the company reports a 10-month-old was strangled by a strap meant to protect children. Twelve different models of Kolcraft play yards are being recalled, as all have the strap.

## 8. Drinking/Drugs

11PM NAT/NEWS 7/3/07 :18

A new government study finds that more than 30 percent of American adults have abused alcohol, or suffered from alcoholism, at some point in their lives. Researches say only 24 percent of alcoholics have received treatment.

5PM NAT/NEWS 7/10/07 :15

A new study found children from neighborhoods with lots of alcohol ads aimed at adults are also appealing to many 8<sup>th</sup> graders. Those students were not only more likely to say they would drink, but they were also less able to name reasons not to drink.

530PM LOC/NEWS 7/25/07 1:27

The Bayanet Team received initial information from informants which continued into a three-month investigation culminating in a drug bust. That raid netted guns, money and drugs and is one of the largest busts made in Isabella County. Five people were arrested.

5PM NAT/NEWS 7/31/07 :17

A new study shows teens are drinking hard liquor when first start drinking, as opposed to beer, because it's easier to hide its consumption and the flavor is tastier to beginners.

NOON LOC/NEWS 8/1/07 :18

Michigan State University received a \$175,000 grant to step up its work in reducing alcohol use on campus. It will use the money to teach other colleges and universities its approach.

WAKEUP NAT/NEWS 8/5/07 :27

Police busted an ice cream vendor for selling cocaine and marijuana out of his delivery truck, right in front of a middle school. Officers also found a gun inside the truck.

530PM LOC/NEWS 8/29/07 :17  
A Michigan State Police trooper used a "precision immobilization technique" to stop a Vehicle after he witnessed the driver throwing a bag of what was later determined to be two ounces of marijuana, out of the window. The chase ended with a collision and guns drawn, all of which was caught on tape.

11PM LOC/NEWS 9/1/07 :18  
A statewide drunk driving crackdown continues through September 3. Besides beefing up patrols, police will also be looking for those with outstanding warrants related to alcohol offenses.

11PM NAT/NEWS 9/27/07 :12  
A federal judge places tighter restrictions on the Atlanta Falcons' quarterback, after he tests positive for marijuana.

530PM NAT/NEWS 9/28/07 :23  
An 18-month-old boy is in critical condition tonight, after police say he swallowed some drugs in a home, where marijuana and narcotics were also found. The parents have been charged, and could get seven years in prison.

## 9. Sex Offenders/Predators

11PM LOC/NEWS 7/6/07 3:41  
TV5's I-Team uncovered more than 20 registered sex offenders living less than three quarters of a mile from several mid-Michigan camps. Our research found more than 36 sex offenders living near the Midland Community Center, with 16 of them only a few blocks from the center.

6PM LOC/NEWS 7/17/07 1:30  
A mid-Michigan paramedic is accused of raping a patient while she was being transported to a local hospital. Police say the man picked up the teen after an incident at An Arenac County lake, and then assaulted her while she was strapped in the back of the ambulance.

NOON LOC/NEWS 7/18/07 :17  
The owner of a home daycare center in Adrian has pleaded guilty to five counts of criminal sexual conduct against children. The 52-year-old man videotaped himself sexually abusing at least three infants.

5PM LOC/NEWS 7/24/07 :22  
A Redford man will spend at least 20 years in prison for first degree criminal sexual conduct involving a 13-year-old Durand girl. He is currently serving time for a similar crime in Wayne County.

- 5PM LOC/NEWS 8/7/07 :19  
A registered sex offender is in jail in Isabella County tonight, after he allegedly falsified the registration act. He had been living in Wademan after the registry showed him living in Alma.
- 11PM LOC/NEWS 8/20/07 :18  
A convicted sex offender living in mid-Michigan is arrested for living too close to a school. Troopers arrested a 26-year-old man for living within a thousand feet of a school.
- 11PM NAT/NEWS 8/29/07 2:30  
Back in June, Senator Larry Craig (Rep) from Idaho was accused of lewd behavior in a Minneapolis men's room. The official police report states Craig was peeking into stalls and swiping his hand under the stall divider. Mr. Craig originally pleaded guilty to a misdemeanor but now says his judgement was clouded at the time because of stress.
- WAKEUP NAT/NEWS 9/1/07 1:48  
Earlier this week, when news of Larry Craig's lewd behavior charges and guilty plea became known, he publicly professed his innocence. Since then, reports of his decision to leave office were leaked Friday through Republican officials. A successor to complete Mr. Craig's term has already been chosen.
- 11PM LOC/NEWS 9/10/07 :24  
Central Michigan University police are on the lookout for a man who attacked an 18-year-old who was walking home after an off-campus party in the early morning hours. It happened near the Towers residence hall.
- 530PM LOC/NEWS 9/18/07 :51  
An Assistant U.S. attorney from Florida is under arrest, after flying to Detroit to allegedly have sex with a five-year-old girl. The FBI and local authorities say a 53-year-old man was caught in the internet sting.
- 11PM LOC/NEWS 9/20/07 :25  
An 11-year-old boy from Howell is facing charges for forcing a 7-year-old boy to perform oral sex on him and a 9-year-old boy while on a school bus in May.
- 11PM LOC/NEWS 9/28/07 1:08  
A convicted sex offender is under arrest for living too close to a Mt. Pleasant school. The man was living just over 800 feet from Sacred Heart Academy in Mt. Pleasant.

## 10. School/Campus Improvements/Security

11PM LOC/NEWS 7/12/07 1:10  
The Saginaw School Board decided to postpone the vote for who would install and maintain a new security system in their schools. It will cost the district around \$500,000 and would be installed at Saginaw High, Arthur Hill and the new Thomas Middle School.

530PM LOC/NEWS 7/19/07 :20  
St. Charles Community Schools are looking to ban cell phones from students on school grounds. The superintendent plans to present a proposal to the Board of Ed before the beginning of the school year.

NOON LOC/NEWS 7/20/07 :23  
Right now two Buena Vista teens face possible charges after allegedly bringing guns to summer school. Police received a tip which led to a 17-year-old with a weapon, and at the same time discovered another student with a fake gun. Both youths are now in the Saginaw County Juvenile Detention Center.

6PM LOC/NEWS 7/30/07 :34  
The Grand Blanc School District wants to monitor what children do online at school and at home. If approved, the district would monitor internet postings that directly affect the school. The measure comes after some students posted negative comments about teachers on the web.

6PM LOC/NEWS 8/18/07 1:39  
A group of residents are collecting signatures to recall four Caro school board members. It all stems from the Board approving a variance to the nepotism policy, which forced one school principal to move to a different school.

5PM LOC/NEWS 8/24/07 1:00  
The Clare High School football coach is suspended, without pay, for one semester from his teaching and coaching position. In May last year, a student told him about an assault, but also asked him not to tell anyone, which the coach did not, resulting in the suspension. The coach has found a job as assistant coach at Alma College.

530PM LOC/NEWS 8/29/07 1:20  
There is a new entrance at Saginaw High which allows security to more effectively monitor student activities. Ninety security cameras are also being installed as well as new lighting in the parking lots. All of the changes will cost taxpayers about \$3.2 million. All renovations should be completed by the first day of school.

## **ISSUES AND PROGRAMS REPORT**

### **OVERVIEW**

The report is based on ten significant problems and needs determined by WNEM's community ascertainments. Below each problem/need is a brief description of some news segments broadcast during the quarter designed to call attention to, or address, the problem or need.

The Jobs Bank is expected to be a key issue between automakers and the UAW. The Program costs millions to operate and was created in exchange for the UAW's help in making auto plants more flexible and automated.

Many companies who build highways across the state are laying off workers. Several factors, including a weak Michigan economy have left less money available to fund infrastructure projects.

Investors in Flint have announced that hundreds of jobs could be coming to the area. The Buick City complex, which has sat vacant since 1999, could now become an international hub for business, creating many jobs in the process.

Investors in Flint have announced that hundreds of jobs could be coming to the area. Mid-Michigan Global Link wants to turn the 220-acre Old Buick City site into a freight center, that can handle "rail to freight" shipping traffic. It will be called the Great Lakes Global Gateway, and will create up to 600 new jobs.

Recent coal-mining cave-ins are reminders that coal mining can be life-risking work. Professions that are high on the "deadliest jobs" list are fisherman, loggers, iron and steel works, and coal miners. Following these top contenders are refuse collectors, farmers and ranchers, power line workers, roofers, and people who drive a lot for their jobs.

11PM LOC/NEWS 8/13/07 1:12

The Saginaw County Community Mental Health Authority is looking at possible outsourcing of jobs. Leaders of their union say the outsourcing could lay off almost 70 workers and cut services to the disabled. Union members are willing to accept pay and benefit cuts to keep their jobs.

6PM LOC/NEWS 8/29/07 1:20

The news Saginaw Chippewa gambling facility in Arenac County will employ 300 workers. The job list includes everything from managerial and maintenance positions to working food service and security. This employment will spawn growth for the surrounding communities of Standish and Pinconning.

530PM LOC/NEWS 9/7/07 :16

A new report shows three Michigan colleges generated about 68,000 jobs and contributed nearly \$13 billion to the State's economy last year. U of M, MSU and Wayne State are the three that spark the State's economy.

11PM LOC/NEWS 9/23/07 :20

Joblessness in Michigan, already at its highest rate since 1993, is likely to get worse in the months ahead. According to a new U of M forecast, economists say Michigan is likely to lose nearly 69,000 jobs this year, which is 20,000 more lost jobs than was predicted for 2007 in May's forecast.

**2. Economy/Budgets**

530PM LOC/NEWS 7/10/07 :21

The Flint City Council tabled discussion on nearly all 2008 budget items until July 23. This delay threatens to jeopardize key funding projects such as a nearly \$7 million grant for road improvements. The Council and Mayor Don Williamson have been at odds over spending priorities.

6PM LOC/NEWS 7/16/07 1:25

The Michigan Secretary of State, Terry Lynn Land, has announced she plans to close the Secretary of State office located in Buena Vista Township, and install automated Machines to help distribute license tabs. For all other transactions, folks will have to travel to the Saginaw Township branch.

NOON LOC/NEWS 7/18/07 :10

State lawmakers are back in Lansing from vacation to face Michigan's \$1.6 billion budget deficit. The fiscal year starts October 1. Governor Granholm is pushing for prompt legislative action.



NOON LOC/NEWS 9/10/07 :19  
State legislators and Governor Granholm discuss the best way to close a \$1.75 billion deficit before the start of the next fiscal year. Republicans who run the Senate, Democrats who control the House, and the Governor's office are divided over various tax increase plans.

WAKEUP LOC/NEWS 9/14/07 :18  
The State House is expected to vote today on a proposal to raise personal income taxes. Other ideas being discussed include imposing a tax on services and entertainment. This comes as lawmakers try to balance the budget for the upcoming fiscal year.

6PM LOC/NEWS 9/17/07 :26  
Lawmakers are deadlocked on a proposal to raise the State's income tax from 3.9 percent to 4.6 percent. That would eliminate a large part of a budget deficit projected for next fiscal year, which begins October 1. Despite a very long weekend of negotiations, there has been little visible progress.

11PM LOC/NEWS 9/26/07 1:54  
The State of Michigan is just five days away from a government shutdown, unless a budget deal is reached. Right now, lawmakers need to come to a consensus on how to balance the \$1.75 billion deficit. If the deal isn't reached, the paperwork of shutting down an entire state will begin.

11PM LOC/NEWS 9/30/07 1:39  
The main issue of the new budget is whether or not to raise taxes. Raised taxes will extend the budget and buy lawmakers time to balance it. Another aspect of the agreement would be to apply Michigan's 6 percent sales tax to a number of services, like cable television.

### 3. Crime

11PM LOC/NEWS 7/11/07 1:13  
Two young girls were approached today by a man driving a black pickup truck. The 7-year-old sensed something wasn't right, grabbed her sister's hand and they ran towards their Corunna apartment. Police sent out a bulletin, telling officers to keep an out for the vehicle with a description of the driver. The suspect was never found, which has parents worried.

11PM LOC/NEWS 7/12/07 1:15  
The Crime Prevention Council encourages groups to be aware of crime in their neighborhood. The Covenant Neighborhood Association cares enough to team up with local law enforcement, promoting clean ups of vacant lots and abandoned homes, which are crime magnets.

5PM NAT/NEWS 7/16/07 1:20  
As Americans face new terrorist threats, U.S. cities are eyeing up high tech surveillance systems, like the new \$90 million New York initiative which installed 3,000 cameras. The cameras track car movements with technology that recognizes and records every license plate seen. The new program includes face recognition and helmet cameras.

NOON LOC/NEWS 7/26/07 :21  
A committee called "Parishioners on Patrol" is preparing to host a street witness training session. Attendees will learn guidelines for effective observation of street crimes.

6PM LOC/NEWS 8/1/07 1:17  
Witnesses tell Saginaw police of shots fired in a Bridgeport hotel parking lot, and then a fight ensues inside the building, while guests scrambled to safety. A 17-year-old Saginaw resident suffered gunshot wounds that were non-life threatening.

11PM LOC/NEWS 8/15/07 1:54  
A young mother's life was taken in the early morning hours, marking the 14<sup>th</sup> shooting for the City of Saginaw this year. A local minister forms a movement called "Save Ourselves" which now has approximately 50 members. They hold rallies and meetings, and even attend funerals of gang members, hoping to connect in a positive way.

11PM LOC/NEWS 8/16/07 1:15  
A 26-year-old woman was killed and her 22-year-old brother critically injured outside a house on North Webster Street. The incident happened after the siblings attended a birthday party at the home. The woman leaves behind five children.

5PM LOC/NEWS 9/17/07 :17  
The Saginaw and Flint Police Department will receive federal money to help fight gun violence and gangs. The \$1 million grant will be split between Saginaw, Flint and the Jackson, Michigan departments.

NOON LOC/NEWS 9/19/07 :29  
This morning, State Police continue to investigate a fatal shooting at the Lone Pine Motel in Clare. A tazer was used before firing upon William C. Scozari, killing him. The two officers were responding to a complaint of shots being fired, when the suspect allegedly lunged at police with a knife and hatchet.

11PM LOC/NEWS 9/27/07 :35  
Earlier today, on Dearborn Street, shots were fired, sending one right through the window of Masters Court Ministries and a nearby home. Officers did find a gun behind a home. No arrests have been made.

The mother of a 3-year-old, who accidentally shot and killed himself, may not face any criminal charges, although she may lose custody of her two other children. The Genesee County prosecutor concluded, after months of investigation, the boy pulled the trigger of a 9 MM gun on his own.

#### 4. Abuse

5PM    LOC/NEWS                      7/11/07                      :17

A former Essexville-Hampton school custodian has been bound over for trial. He is accused of slamming a 7-year-old boy into a chair, when the boy called him a name. The misdemeanor could lead to 93 days in jail, and a \$500 fine.

5PM    NAT/NEWS                      7/16/07                      1:25

Victims abused by Catholic priests quietly made their way into a Los Angeles courthouse today. The victims will each receive about a million dollars, but not full satisfaction, as many of the victims wanted full disclosure. The deal will avoid potentially embarrassing revelations in court. More than \$2 billion has been paid out by the Roman Catholic Church for similar cases of abuse.

There has been a delay in the case against a Lapeer County family accused of animal abuse. Three dogs were confiscated during a March raid of a farm in Imlay Township.

11PM    NAT/NEWS                      8/10/07                      1:20

A property manager was arrested after 18 residents were discovered living in an area designated for six residence. The occupants all suffered from heat-related illnesses. The property was operating as an unlicensed assisted living facility, say city officials.

5PM    NAT/NEWS                      8/15/07                      :19

Nearly 90 cats and dogs were discovered inside a multi-million dollar New Jersey mansion, along with 23 dead animals in shoe boxes, stacked in the garage. The owners are now facing animal cruelty charges.

6PM    LOC/NEWS                      8/24/07                      :18

A St. Charles teen is accused of killing two animals and will undergo a psychological examination for feeding them antifreeze. The girl was enrolled in the Veterinary Technician program at Baker College at the time.

11PM    LOC/NEWS                      9/1/07                      :20

A Flint woman faces felony charges for allegedly throwing her neighbor's dog off a 20-foot balcony. The woman faces charges of torturing an animal, a 4-year felony.

530PM NAT/NEWS 9/17/07 :26  
The Roman Catholic diocese of Pittsburgh has created a fund with more than a million dollars in it, to settle 32 lawsuits alleging abuse or injury by priests. The diocese will also offer a program of counseling and healing.

WAKEUP LOC/NEWS 9/18/07 :19  
A Flint woman accused of throwing her roommate's dog off a second floor balcony is pleading "not guilty." If convicted, she faces a two-year sentence. Sadie Mae, the nine-pound puppy, is recovering.

## 5. School Budgets

5PM LOC/NEWS 7/11/07 :16  
Alma Schools are deciding what to do with a million dollar windfall. That's how much was left over after building and remodeling projects came in under budget.

11PM LOC/NEWS 7/14/07 :11  
In Genesee County, the Flint School District received \$750,000 in federal money to fund after-school programs. The youth development programs will include academic and recreational activities.

WAKEUP LOC/NEWS 8/7/07 :19  
A health foundation is giving Michigan and 16 other states \$20 million to promote healthy eating and exercise in schools. The Alliance for a Healthier Generation hopes to attack obesity in children.

6PM LOC/NEWS 8/9/07 :25  
A protest was held by more than a dozen Saginaw School District educators. It happened as an \$8 million budget deficit has forced the school board to cut back on programs.

WAKEUP LOC/NEWS 8/10/07 :24  
There are two six-year terms that will be on the ballot this November. So far only two District residents have requested nomination petitions. The Board is open to people who live in the City of Saginaw, Zilwaukee and Kochville Township.

530PM NAT/NEWS 8/17/07 1:30  
The average family plans to spend just under \$564 this year on back-to-school shopping, Seven percent more than last year. The bulk of the money will go for clothing. Experts say once school starts retailers tend to cut prices, so parents should wait for the bargains.



11PM LOC/NEWS 8/9/07 1:09  
After more than 8 months in Iraq, a soldier returns home and meets his 8-month-old daughter for the first time. The baby was born just one week after Corporal Zachary Wegley of Saginaw County was deployed to Iraq. Wegley will return to duty in two weeks.

11PM LOC/NEWS 8/11/07 1:30  
A community came out to show support for a local fallen hero. Hundreds attended a memorial in Saginaw County for 23-year-old Army Private First Class Charlie Heinlein. Those who knew him, say you can serve his memory by reaching out to servicemen overseas, with a letter or a care package.

11PM LOC/NEWS 8/17/07 1:25  
About 150 families gave their loved ones a hero's welcome at Ferris State University's Wink Arena. It was the 1<sup>st</sup> Battallion 125<sup>th</sup> Infantry Regiment in the Michigan Army National Guard returning home after a year in Iraq.

11PM LOC/NEWS 9/10/07 1:19  
The top U.S. military commander in Iraq, General David Petraeus, presented his report card on the progress of the war, at a Congressional hearing. He said the military objectives of the recent troop build-up, for the most part, are being met.

5PM LOC/NEWS 9/18/07 1:39  
Clare residents say he was a big guy with a big heart. They were referring to Specialist E-4 Tom Motley who lost his life while serving his country. And when he left Pioneer High School, he didn't forget where he came from, because when he came home on leave, he visited the school, and was interviewed by the Media Production class.

530PM LOC/NEWS 9/26/07 :14  
A church and gift store in Traverse City are sending a quarter ton of cherries to soldiers in Iraq and Afghanistan. Some local youth groups will pack the fruit for shipment.

## 7. Recalls

WEEKEND WAKEUP NAT/NEWS 7/14/07 :17  
Gerber is pulling two of their cereals off store shelves after several reports of choking. Apparently some packages contain lumps of cereal that don't dissolve in milk.

WAKEUP NAT/NEWS 7/23/07 :24  
The Castleberry Food Company is recalling more than 80 types of chili and canned meat products. The FDA warns consumers the products may be tainted with a potentially fatal bacteria than can cause botulism. At least four people have gotten sick from the products.

5PM LOC/NEWS 7/23/07 1:30  
A major meat recall affects most of our viewing area. Abbott's Meats Incorporated, based in Flint, is recalling tens of thousands of pounds of meat that could make you sick. Abbott's Meats are sold in Genesee, Saginaw, Bay, Midland, Lapeer and Ingham County stores.

11PM NAT/NEWS 8/4/07 1:37  
The United States and China are trying to agree on safety standards for Chinese imports. The meetings were prompted by a series of recalls of contaminated imports, including millions of children's toys, with lead paint being one of the main problems.

NOON NAT/NEWS 8/8/07 :20  
A New York company is recalling two kinds of toothpaste. The toothpaste was made in China and may contain a chemical, toxic to the kidneys and liver.

5PM LOC/NEWS 8/14/07 1:09  
Some parents are having trouble exchanging recalled toys—the reason is that kids love playing with them. This woman has two daughters who did not wish to part with their Polly Pockets. Fortunately, the Polly Pockets do not involve lead, just loose magnets. If two magnets are swallowed, they can attract to each other, causing a serious blockage. Mattel says at least three children have had surgery for that very reason.

5PM LOC/NEWS 8/15/07 1:06  
There is a test kit, which costs about \$4, to make sure your child's toys are safe. It is for sale at hardware stores and home improvement stores and is simple to use. It checks to see if there is any lead in the paint used on your child's toys.

11PM NAT/NEWS 8/30/07 :17  
A California produce company is recalling bagged fresh spinach after a sample tested positive for salmonella. So far, there have been no reports of illness linked to the tainted spinach.

6PM LOC/NEWS 9/1/07 1:22  
Kroger is recalling all of its Kroger brand mustard and southern-style potato salad, with a "best if used by" date of September 5, 2007, because it may contain e-coli. Kroger Voluntarily pulled it as a precautionary method and are urging customers to check their refrigerators to see if they have purchased it. It can be brought back for a full refund.

5PM NAT/NEWS 9/5/07 1:30  
Mattel has issued another call for 800,000 toys, made in China, with too much lead paint. The products include Barbie furniture, the GEO trax locomotive and Bongo Band drums. Popular Barbie dolls were not recalled. This is the third time in five weeks that Mattel has been forced to recall toys.

11PM NAT/NEWS 9/22/07 :25  
About one million Simplicity and Graco cribs are being recalled. The announcement comes after the deaths of three children. The Consumer Product Safety Commission Says the three became entrapped in their cribs and died of suffocation. It appears the drop-rail side of the crib was upside down.

5PM NAT/NEWS 9/28/07 1:15  
Kolcraft playpens are being recalled as the company reports a 10-month-old was strangled by a strap meant to protect children. Twelve different models of Kolcraft play yards are being recalled, as all have the strap.

## 8. Drinking/Drugs

11PM NAT/NEWS 7/3/07 :18  
A new government study finds that more than 30 percent of American adults have abused alcohol, or suffered from alcoholism, at some point in their lives. Researches say only 24 percent of alcoholics have received treatment.

5PM NAT/NEWS 7/10/07 :15  
A new study found children from neighborhoods with lots of alcohol ads aimed at adults are also appealing to many 8<sup>th</sup> graders. Those students were not only more likely to say they would drink, but they were also less able to name reasons not to drink.

530PM LOC/NEWS 7/25/07 1:27  
The Bayanet Team received initial information from informants which continued into a three-month investigation culminating in a drug bust. That raid netted guns, money and drugs and is one of the largest busts made in Isabella County. Five people were arrested.

5PM NAT/NEWS 7/31/07 :17  
A new study shows teens are drinking hard liquor when first start drinking, as opposed to beer, because it's easier to hide its consumption and the flavor is tastier to beginners.

NOON LOC/NEWS 8/1/07 :18  
Michigan State University received a \$175,000 grant to step up its work in reducing alcohol use on campus. It will use the money to teach other colleges and universities its approach.

WAKEUP NAT/NEWS 8/5/07 :27  
Police busted an ice cream vendor for selling cocaine and marijuana out of his delivery truck, right in front of a middle school. Officers also found a gun inside the truck.



5PM LOC/NEWS 8/7/07 :19  
A registered sex offender is in jail in Isabella County tonight, after he allegedly falsified the registration act. He had been living in Wademan after the registry showed him living in Alma.

11PM LOC/NEWS 8/20/07 :18  
A convicted sex offender living in mid-Michigan is arrested for living too close to a school. Troopers arrested a 26-year-old man for living within a thousand feet of a school.

11PM NAT/NEWS 8/29/07 2:30  
Back in June, Senator Larry Craig (Rep) from Idaho was accused of lewd behavior in a Minneapolis men's room. The official police report states Craig was peeking into stalls and swiping his hand under the stall divider. Mr. Craig originally pleaded guilty to a misdemeanor but now says his judgement was clouded at the time because of stress.

WAKEUP NAT/NEWS 9/1/07 1:48  
Earlier this week, when news of Larry Craig's lewd behavior charges and guilty plea became known, he publicly professed his innocence. Since then, reports of his decision to leave office were leaked Friday through Republican officials. A successor to complete Mr. Craig's term has already been chosen.

11PM LOC/NEWS 9/10/07 :24  
Central Michigan University police are on the lookout for a man who attacked an 18-year-old who was walking home after an off-campus party in the early morning hours. It happened near the Towers residence hall.

530PM LOC/NEWS 9/18/07 :51  
An Assistant U.S. attorney from Florida is under arrest, after flying to Detroit to allegedly have sex with a five-year-old girl. The FBI and local authorities say a 53-year-old man was caught in the internet sting.

11PM LOC/NEWS 9/20/07 :25  
An 11-year-old boy from Howell is facing charges for forcing a 7-year-old boy to perform oral sex on him and a 9-year-old boy while on a school bus in May.

11PM LOC/NEWS 9/28/07 1:08  
A convicted sex offender is under arrest for living too close to a Mt. Pleasant school. The man was living just over 800 feet from Sacred Heart Academy in Mt. Pleasant.

**10. School/Campus Improvements/Security**

11PM LOC/NEWS 7/12/07 1:10  
The Saginaw School Board decided to postpone the vote for who would install and maintain a new security system in their schools. It will cost the district around \$500,000 and would be installed at Saginaw High, Arthur Hill and the new Thomas Middle School.

530PM LOC/NEWS 7/19/07 :20  
St. Charles Community Schools are looking to ban cell phones from students on school grounds. The superintendent plans to present a proposal to the Board of Ed before the beginning of the school year.

NOON LOC/NEWS 7/20/07 :23  
Right now two Buena Vista teens face possible charges after allegedly bringing guns to summer school. Police received a tip which led to a 17-year-old with a weapon, and at the same time discovered another student with a fake gun. Both youths are now in the Saginaw County Juvenile Detention Center.

6PM LOC/NEWS 7/30/07 :34  
The Grand Blanc School District wants to monitor what children do online at school and at home. If approved, the district would monitor internet postings that directly affect the school. The measure comes after some students posted negative comments about teachers on the web.

6PM LOC/NEWS 8/18/07 1:39  
A group of residents are collecting signatures to recall four Caro school board members. It all stems from the Board approving a variance to the nepotism policy, which forced one school principal to move to a different school.

5PM LOC/NEWS 8/24/07 1:00  
The Clare High School football coach is suspended, without pay, for one semester from his teaching and coaching position. In May last year, a student told him about an assault, but also asked him not to tell anyone, which the coach did not, resulting in the suspension. The coach has found a job as assistant coach at Alma College.

530PM LOC/NEWS 8/29/07 1:20  
There is a new entrance at Saginaw High which allows security to more effectively monitor student activities. Ninety security cameras are also being installed as well as new lighting in the parking lots. All of the changes will cost taxpayers about \$3.2 million. All renovations should be completed by the first day of school.







Kelee was allowed to plead guilty to three lesser charges: accessory to murder and two counts of perjury. She was sentenced to four years in prison. Malia is being raised by her paternal grandparents, Richard and Susan Davidson. Kelee Davidson is expected to be released from prison in July 2007. She is hoping to regain custody of Malia. Heather was immediately certain that ex-husband Ron was involved in the crime, as he had once threatened to make her pay for leaving him. Investigators were able to track down three men who they believed were involved in the assault: Hugh Estess, the car owner; Eddie Stafford, the driver, and Roger Runyon, the shooter. Also implicated was Geoff Pollock, who was present at meetings when the crime was discussed. Ron Samuels was named as the man behind the crime - the puppet master. In exchange for complete immunity, police got the co-conspirators to acknowledge Samuels' lead role in the crime. Before Samuels could be arrested, he fled to Mexico. He ran afoul of the law there when police found six kilos of cocaine in his car. He was imprisoned and, five years later, still proclaiming his innocence, he was extradited to the U.S. to stand trial for the attempted murders. He was found guilty of all charges and sentenced to life in prison for the attempted murders, plus an additional 120 years for the other charges. The court ordered Samuels to pay Heather restitution, but he claims that he's broke. Investigators are tracking any remaining assets. He is planning to appeal his conviction. Within 48 hours, Wesley Wayne Miller was charged with the murder of Retha Stratton. Initially, Miller denied involvement, but once presented with the evidence, he confessed. Stratton had not been sexually assaulted, but police were able to match Miller's fingerprints to one of the sexual assault crime scenes. The murder trial began in October of 1982 and two weeks later, Miller was found guilty and sentenced to twenty five years in prison. The jury in the murder trial was prohibited from hearing anything concerning the sexual assaults and believed he deserved a second chance. Without DNA testing, prosecutors went forward with the most airtight sexual assault case, but eventually agreed to a plea deal of twenty years, which would be served concurrently with the murder sentence. Rona Stratton, Retha's sister and Lisa Ticknor Gabbert, a close friend of Retha's and one of Miller's victims were devastated to learn just how quickly Miller would become eligible for parole and made it their mission to keep Miller in prison. By 1991, due to a mandatory release law established to ease prison overcrowding, Miller had enough credit for good behavior and qualified for early release. Miller was arrested again for attempted assault and sentenced to five more years. Released again in 1998 to a county jail, Miller refused to attend sex offender counseling and as a result, was returned to prison. With his twenty five year sentence almost over, Rona and Lisa attempted to have Miller classified as a sexually violent predator under civil commitment - a law which Rona was instrumental in getting passed. Two convictions for sex crimes are required in order to be committed and if successful, Miller would become the first murderer to be classified as such. Chief Prosecutor Joey Robertson argued that Retha's murder was the very definition of a sex crime and was the last barbaric act of a serial rapist. The jury agreed. As a result, upon Miller's release, he will be subject to the same intense monitoring as the worst sex offenders. On March 9, 2007, Wesley Wayne Miller was released from prison. Stanko claimed he had no memory of these events. At his trial for the murder of Laura Ling, Stanko's lawyer called on medical experts who claimed that PET scan images of Stanko's brain revealed that he was born with a brain defect, a neurological dysfunction that made him psychopathic and, on occasion, temporarily insane. Medical experts for the prosecution contested this claim. A jury found Stanko guilty and recommended the death penalty. He will again face the death penalty when he is tried for the murder of Henry Turner. His lawyer will continue to argue that he has a brain defect. **48 HOURS MYSTERY: "To Catch A Killer"** - On December 3, 1997, when several family members didn't show up for a birthday party, Phil and Nicoletta Dosso drove to their business in Bartow, Florida to search for them. There, they made a grisly discovery - the bodies of their daughter, Diane Patisso; her husband, George Patisso; their son, Frank Dosso; and their longtime business partner and friend, George Gonsalves. All four of them had been shot execution style and the killer had been extremely careful - no fingerprints, DNA or murder weapon was found. Special Agent Tommy Ray investigated more than one thousand leads, but all were dead ends except for one - Nelson Serrano. Serrano, a former business partner, had been accused of theft by Dosso and Gonsalves and eventually forced out. But Serrano had an alibi - he claimed to have been in Atlanta, Georgia at the time of the murders. However, hotel lobby video footage from Atlanta, cell phone records, an admission by Serrano's nephew, Alvaro Pennaherrera that he rented a car for his uncle, as well as Serrano's fingerprints on two airport parking tickets from Orlando, Florida further cemented Ray's belief in Serrano's guilt. Four years after the homicides, Serrano was indicted. However, months earlier, Serrano and his wife had returned to their native Ecuador - a country with no extradition treaty with the United States. Special Agent Ray traveled to Ecuador to see if there was a loophole which would allow him to arrest Serrano. One came after it was revealed that Serrano had given up his Ecuadorian citizenship when he had become a US citizen. With that information, Serrano was arrested and deported back to the United States. Serrano and his family claimed that his Ecuadorian citizenship was reinstated when Ecuador's constitution was changed and that he was denied an attorney. Nine years after the killings, Serrano went on trial. The jury reached a verdict in only six hours - guilty of four counts of first-degree murder. Nelson Serrano is under a suicide watch while he awaits sentencing. Ecuadorian legislators want to investigate Nelson Serrano's deportation to the United States. **48 HOURS MYSTERY: "Murder on the Cape"** - a follow-up to "Secrets of the Heart" (OAD: 04/10/02; rebroadcast on 08/05/02 with an update.) In January 2002, Christa Worthington, a former fashion writer, was found murdered in her Truro, Massachusetts home. The expanding list of potential suspects included her former boyfriend, Tim Arnold, who had discovered her body; and ex-lover Tony Jackett, a married father of five children, whose affair with Worthington produced a daughter named Ava. DNA evidence was found on Worthington's body indicating sexual relations, but when the crime lab produced results a year after her murder, they did not match any of the potential suspects. With no match, District Attorney Michael O'Keefe widened the circle of his investigation and asked for DNA from every single man in Truro. Three and a half years after the murder, a match was found for the DNA located both inside and outside Worthington's body. Christopher A. McCowen, Worthington's garbage man, was arrested for her murder. McCowen denied knowing Worthington until he was presented with the DNA evidence against him. With that information, McCowen admitted to having had sexual relations with Worthington and that he had beat her, but he blamed her murder on his friend, Jeremy Frazier. However, Frazier's DNA wasn't found anywhere on Worthington's body and he had an alibi. McCowen's attorney, Bob George, believed that McCowen's race, class, drug use, and low IQ made him an easy target and that McCowen and Worthington had been involved in a consensual sexual relationship. George believed that the police had bungled the investigation and that the case was based on the inability to imagine an actual relationship between the two. McCowen never testified. The jury found him guilty of first degree murder and sentenced him to life in prison without the possibility of parole. Attorney Bob George claims he has evidence of racial bias on the jury and has filed a motion for a new trial. (C: Susan Spencer - P: Josh Yager, Martin Zied) (OAD: 03/06/07)

**48 HOURS MYSTERY: "The McGuire Diaries"** - Melanie McGuire, on trial for the murder of her husband Bill, was provided by 48 HOURS MYSTERY with a video camera, so that she could record her intimate thoughts as she stood trial. Excerpts of her video diary are interspersed throughout the broadcast. In May of 2004, his dismembered body was found in three suitcases in Chesapeake Bay. He had been shot with a .38 caliber gun. Melanie claimed that Bill had vanished weeks before, after an argument. She had never filed a missing person's report and without having heard from Bill, she later filed for divorce. She claimed that he had been abusive and suggested that his disappearance and murder were the result of his gambling problem and that his frequent trips to Atlantic City had put him in contact with shady characters. However, a blanket wrapped around Bill's torso was the same kind of blanket used at the fertility clinic where Melanie worked as a nurse, making her a suspect. After extensive searches, police were unable to find a murder weapon or tool used to cut up Bill's body, and there was no evidence of a crime scene. Soon afterwards, police learned that Melanie had purchased a Taurus .38 special revolver just 48 hours before Bill had disappeared. Melanie, however, claimed that she had purchased that gun for Bill at his own request. She claimed he wanted it for his own protection, but couldn't buy it himself because of a felony conviction. Believing her to be guilty, Prosecutor Patti Prezioso intensified her investigation and had Melanie put under surveillance. This soon revealed two of Melanie's secrets — she had been carrying on an affair for more than two years with her boss, Dr. Brad Miller, and she had been in Atlantic City the night after she claimed Bill had left her. She later stated that she had gone to Atlantic City in search of Bill, had found his car and moved it out of spite. Thirteen months after the suitcases were found, Melanie McGuire was arrested for the murder of her husband. Nine months after her arrest, the trial began. After seven weeks and more than seventy witnesses, Melanie McGuire was found guilty and sentenced to life in prison. She will be eligible for parole in 2073, when she would be 100 years old.
