In the period from April 1, 2006 through June 30, 2006, KCNC-TV broadcast the following programs originally produced and broadcast for children 12 years of age and under:

- (1) With respect to the program supplied by the CBS Television Network (see attached statement), the station broadcast such programs as formatted and scheduled by the network without adding any commercial time in excess of the statutory commercial limits, or otherwise scheduled such programs at a time and in a sequence so as to comply with these limits.
- (2) With respect to programs supplied by syndicators or produced by the station, such programs were formatted and broadcast within the statutory commercial limits.

During the above period, the CBS Television Network ("CBS"), a unit of Viacom Inc., disseminated to its owned and affiliated stations the following weekly programs originally produced and broadcast primarily for an audience of children 12 years of age and under:

DORA THE EXPLORER
LITTLE BILL
BLUE'S CLUES
THE BACKYARDIGANS
GO, DIEGO, GO

All of these programs were disseminated for weekend broadcast by CBS affiliates and owned stations.

I hereby certify that the children's programming disseminated by CBS during the period April 1, 2006 through June 30, 2006, was formatted to contain no more than the maximum amount of commercial time permitted under the Communications Act, as amended, 47 U.S.C. §303a, and 47 C.F.R. §73.670. Specifically, I certify that, in the form and sequence in which the programming was disseminated by CBS to its owned and affiliated stations for broadcast:

- (1) Each hour of weekend children's programming (containing either one hour-long program or two consecutive half-hour programs) contained no more than ten and one-half minutes (10:30) of network commercials and was formatted to contain no commercials supplied by the local station;
- (2) When, due to preemptions, the network disseminated during the weekend a half-hour children's program which was not part of an hour's block of children's programming, that program contained no more than five minutes fifteen seconds (5:15) of network commercials and was formatted to contain no commercials supplied by the local station.
