Re: Notification of Network Non-duplication Rights

To the Director of Programming Operations:

Esteem Broadcasting of California, LLC, licensee of KBVU(TV), Eureka, California (the "Station"), located at 730 7<sup>th</sup> Street, Eureka, California 95501 in the Eureka, California television market hereby gives you notice of Station's network non-duplication rights in connection with entering into the Station's affiliation agreement with the FOX television network. The Station holds the exclusive broadcast and cable carriage rights, in a geographic area as specified by FOX that encompasses or may encompass your cable systems, for the FOX programs broadcast by the Station. These rights are effective immediately, and they remain in effect until June 30, 2014.

The Station's network non-duplication rights apply with respect to all FOX programs, in any and all formats (whether digital, analog or otherwise), including those programs broadcast by the Station during the time periods set forth below. These time periods may be subject to change. In addition, the Station holds network non-duplication with respect to other programming that is not regularly scheduled but which is aired by the Station. These network non-duplication rights apply to both simultaneous and non-simultaneous duplication, with respect to all FOX programs during the term of the Station's FOX affiliation agreement (from December 19, 2012 through June 30, 2014). Currently, FOX's regularly scheduled programs are scheduled to air on the following days and time periods (subject to change):

Daytime:	9-10 a.m. 10 a.m.-12 p.m.	Sunday Saturday
Prime Time:	7-10 p.m. 8-10 p.m.	Sunday Monday through Saturday
Late Night:	11 p.m.-12 a.m. 12 a.m.-12:30 a.m.	Saturday Saturday
Weekend, All-Star & Season Sports (including pre-game and post-game shows):		As scheduled for Station by FOX Post

For Daytime Programming, the specified times above apply to all Time Zones. For time periods that than Daytime, the times above apply for the Eastern or Pacific Time Zones, and Mountain and Central time Zones are one hour earlier.





The Station hereby invokes its right under the network non-duplication rules of the Federal Communications Commission, 47 C.F.R. §§ 76.92 - 76.94, to protection from any and all of the cable systems listed above or any others operated by you within 55 miles of Eureka, California (but not including any area outside the Eureka, California Nielsen Media Research Designated Market Area), in the distribution to their customers of any of the programs referenced above, by any means other than by carrying the Station. As noted above, these rights are effective immediately. To the extent that these systems carry a signal that includes programming to which we are entitled to nonduplication protection, they must delete such programming.
