FCC Violation

On March 15, 2006, the FCC issued a *Forfeiture Order* against CBS Corporation (“CBS”),<sup>1</sup> as the licensee or parent corporation of the licensee of a number of television stations, including WCBS-TV, for the broadcast of material during the halftime show of the Super Bowl game on February 1, 2004, which the Commission found to be indecent. The game and halftime were carried by the CBS Television Network and broadcast by WCBS-TV. The show, which was produced by MTV Networks (“MTVN”),<sup>2</sup> contained a musical performance that concluded with Justin Timberlake pulling off part of Janet Jackson’s clothing, which inadvertently (according to Timberlake and Jackson) resulted in the brief exposure of Ms. Jackson’s breast. Despite CBS’s representation, based on an intensive internal investigation, that no CBS or MTVN personnel had prior knowledge of this element of the Jackson-Timberlake performance, the Commission nonetheless found the broadcast to be “willful” under the applicable legal standard, citing, *inter alia*, the principle of *respondeat superior*. CBS filed a petition for reconsideration, which was denied by the Commission in an order released on May 31, 2006.

For purposes of meeting appellate jurisdictional requirements, CBS paid the \$550,000 fine assessed by the *Forfeiture Order* on July 28, 2006. On the same day, CBS filed a petition for review of the FCC’s decision with the United States Court of Appeals for the Third Circuit. The appeal is pending.

<sup>1</sup> The *Forfeiture Order* upheld a *Notice of Apparent Liability* (“NAL”) issued to Viacom Inc. (“Viacom”) on August 31, 2004. At the time of the issuance of the NAL, Viacom was the ultimate corporate parent company of the licensees in question. As of December 31, 2005, Viacom effected a corporate reorganization in which the name of the ultimate parent company of the licensees of the stations subject to the NAL was changed to CBS Corporation. For convenience, the parent company of CBS Broadcasting Inc., the licensee of WCBS-TV, is referred to above as “CBS,” regardless of whether the reference is to a time before or after the above corporate reorganization.

<sup>2</sup> CBS Corporation was under common ownership with MTVN at the time of the broadcast in question.
